# INTRODUCTION

The purpose of this study is to determine the size, scope and impact of the agribusiness industry in the Commonwealth of Pennsylvania.

#### THE STUDY IS DESIGNED TO ANSWER THE FOLLOWING QUESTIONS:

- 1. How many agribusinesses are there?
- 2. What is their economic impact, in terms of sales and employment?
- 3. What is the role of small businesses in the agribusiness industry, in terms of sales and employment?
- 4. What is the impact of agribusiness in Pennsylvania by county, in terms of sales and employment?
- 5. In what subsets of the agribusiness industry do small firms have the greatest impact, in terms of sales and employment?

#### THE FOLLOWING STEPS WERE FOLLOWED FOR THIS STUDY:

- 1. Obtain the definition of agribusiness in consultation with the PA Department of Agriculture
- 2. Determine NAICS codes for agribusinesses
- 3. Inventory agribusiness in Pennsylvania statewide and for each county by:
  - Total number of businesses, sorted by size, sales and employment
  - Total sales sorted by size and employment
  - Total employment sorted by size and sales

#### THE ACTIONS TAKEN TO COMPLETE THIS STUDY INCLUDED:

- 1. Finalize a definition for Agribusiness.
- 2. Convert the data from the Economic Research Service (ERS) input/output codes to SIC to NAICS so the census data could be accessed.
- 3. Determine the major sectors that would be included in this study.
- 4. Enter data into the database for analysis.
- 5. Analyze the data.
- 6. Create a sortable database.
- 7. Prepare the Final Report.

The transitional period from SIC code business classifications to NAICS has resulted in a variation among the agencies on how they report data. A major challenge of this study was to convert the industry data for the industries reported by the Economic Research Services (ERS) to be in the agribusiness sector to the equivalent census data codes which are reported in NAICS. It was necessary to do a conversion between the SIC codes

reported by ERS and NAICS codes. We expect that as the ERS and other agencies adapt to NAICS reporting, this task will be less difficult in the future.

Previously, there have been studies on PA agribusiness that perform an economic analysis based on inputs and outputs which provide multipliers to project growth in various sectors (Penn State, USDA). This study utilized NAICS codes to obtain the dollar value, number of firms and number of jobs by county, where possible.

The goal of this study is to identify how large the agribusiness sector is in Pennsylvania in employment and business size sorted by industry using NAICS codes. This information is further sorted in terms of value, showing the role both employment and business size play in the agribusiness sector.

Because of the large volume of data, this study identifies the county data in groups of the top 10 counties for the major sectors of agribusiness and top 5 counties for the industry subsectors. # **DEFINITION OF AGRIBUSINESS**

After reviewing various sources, the definition of Food and Fiber published by the U.S. Economic Research Service (ERS) has been accepted by the Pennsylvania Department of Agriculture Deputy Secretary as the definition of agribusiness. This study utilizes this definition as the basis for data collection. The following is the definition of agribusiness.

"The food and fiber system comprises the economic activities of the farms and the firms that assemble, process, and transform raw agricultural commodities into final products for distribution to U.S. and foreign consumers. The food and fiber system includes all economic activity that supports farm production and the conversion of raw farm products to consumable goods—for example, machinery repair, fertilizer production, farming itself, food processing and manufacturing, transportation, wholesale and retail trade, distribution of food and apparel, and eating establishments. The income and employment generated within the food and fiber system is the income earned and jobs provided by these firms."

# **DATA LIMITATIONS**

The U.S. Department of Agriculture's Economic Research Service (ERS) reported the 1997 data at the Pennsylvania state level using Input/Output codes bridged to the Standard Industrial Classification codes (SIC). This study utilized this data, extending the codes to the North American Industry Classification System (NAICS) for the major components of the Food and Fiber System: Agriculture, Manufacturing, Wholesale, Retail, Food Services.

Due to the relatively few firms in each NAICS category, the census data does not report the value for the business at the county level for the majority of the data set. This limited the study to reporting county and regional data by establishments and number of employees.

# OVERVIEW OF AGRIBUSINESS IN PENNSYLVANIA

Agribusiness, defined by the Food and Fiber System, consists of the economic activities of the farms and the firms that assemble, process, and transform raw agricultural commodities into final products for distribution to U.S. and foreign consumers. The Food and Fiber System includes all economic activity that supports farm production and the conversion of raw farm products to consumable goods—for example, machinery repair, fertilizer production, farming itself, food processing and manufacturing, transportation, wholesale and retail trade, distribution of food and apparel, and eating establishments. The income and employment generated within the Food and Fiber System is the income earned and jobs provided by these firms. <sup>1</sup>

In 1997, Pennsylvania had 1,044,000 workers and ranked 6<sup>th</sup> in U.S. employment for the Food and Fiber System. This number has decreased over the past two decades. Table 1 illustrates the rank ordering of states most active in the Food and Fiber System and shows a comparison between years 1981 and 1997. Pennsylvania lost 24,000 jobs related to the Food and Fiber System during this period.

TOTAL CIVILIAN EMPLOYMENT BY STATE




Table 2 presents employment data for the Food and Fiber System and the agricultural production sectors. It is interesting to note that Pennsylvania depends on agriculture as the basis for production of many products and ranks 6<sup>th</sup> in employment of total agribusiness workers among the top states. Pennsylvania's employment in the agriculture sector itself is not in the top ten states.

# SECTOR BREAKDOWN WITHIN AGRIBUSINESS IN PENNSYLVANIA

Agribusiness, defined by the Food and Fiber System, in Pennsylvania is \$46.4 billion and creates 1,044,000 jobs. It also represents 4.6% of the total Food and Fiber System in the U.S.

The largest Food and Fiber sectors are Agriculture, Manufacturing, Wholesale, Retail, and Food Services.

The largest dollar value sector of Pennsylvania Food and Fiber is Manufacturing with \$13.5 billion, followed by Retail with \$8.7 billion, and Food Services with \$5.7 billion.

The largest job creator in Pennsylvania Food and Fiber is Retail with 307,152 jobs, followed by Food Services with 264,212 jobs, and Manufacturing with 196,453 jobs.

The following table illustrates the major components of Pennsylvania's Food and Fiber System.

# Top 10 PA Counties for Major Agribusiness Establishments

The following chart depicts the 10 counties with the greatest number of establishments. The data was accumulated by isolating the NAICS code for the agribusiness components of each section mentioned above.

The top PA County for employment in major agribusiness sectors is Allegheny with 96,859 employees, followed by Philadelphia with 60,748 employees. The majority of establishments are quite small, less than 4 employees.

Approximately 10% of PA's employees in the top 10 counties for agribusiness are employed by firms with less than 10 employees and 81% by firms with less than 250.\*

\*NOTE: As seen in the charts, the data for employment is grouped by ranges of employees. An approximate determination of the percentage of employees working in various sizes of businesses can be determined by utilizing the mean of the categories and comparing it with the total.

# PENNSYLVANIA AGRIBUSINESS BY REGION

Since there are 67 counties in Pennsylvania and a listing by county would make reading this study difficult, we decided to group the counties by region in consultation with the PA Department of Agriculture. A separate, searchable, database is available in which individual county data can be viewed. (www.duq.edu/sbdc)

The largest Agribusiness region is the Southeast with 474,204 employees and 26,274 establishments. It is interesting to note that the majority of business establishments for all regions are small. In all of the regions, the largest segment of agribusiness is in the 1-4 employee range followed by 10-49, 5-9, and 50-249.

When using the methods described in the last section it was found that an average of 15% of the state's (all regions) employment is with companies with less than 10 employees and 84% are with firms with less than 250 employees. It is interesting that the percentage of employment by the smallest firms increases when all counties with a smaller number of agribusiness firms are included, rather than just the top 10 counties.

# Percentage by Region

Figure 2 illustrates the percentage of agribusiness in each Pennsylvania region by number of establishments. Half (50%) are in the Southeast region followed by one-fifth (20%) in the Southwest, 12% in the Northeast, 11% in South Central, and 7% in the Northwest.



Figure 3 illustrates the percentage of agribusiness in each Pennsylvania region by number of employees. The Southeast region has the most employees with 52%, followed by 18% in the Southwest, 12% in both the Northeast and South Central, and 6% in the Northwest.




Figure 4 illustrates what percentage of total employees by region are working with small business (less than 250 employees). The Southwest region has the most employees with 96% of its work force hired by small business, followed by 94% in the South Central, 80% in the Southeast, 77% in the Northwest, and 76% in the Northeast.





# The Top 10 PA Counties for Establishments by Major Agribusiness Sectors

In terms of number of establishments, Lancaster is the top county in the agriculture sector with 4,556 total establishments. Philadelphia is the top county in establishments for manufacturing, retail trade, and food services with 426, 2,660 and 2,793 establishments respectively. Allegheny County led wholesale trade with 647 establishments.

# **CONCLUSION**

Based on our findings, the entire Food & Fiber System accounts for \$46.4 billion and employs over 1 million people in Pennsylvania.

The predominant region for agribusiness is the Southeast, followed by Southwest, Northwest, South Central, and Northeast.

The largest agribusiness sector in value is manufacturing with \$13.5 billion and 196,453 employees. The largest agribusiness sector in employment is retail with 307,152 employees but the second in value with \$8.7 billion.

The most predominant business size is 1-4 employees with 22,549 establishments. This is followed by 10-49 employees with 15,175 establishments of this size. Also, it was concluded that approximately 84% of Pennsylvania's agribusiness workforce is employed by businesses with less than 250 employees. Fifteen percent of the workforce is employed by businesses with ten employees or less. This data demonstrates how important small businesses are for the Pennsylvania agribusiness sector.
